Public Notice

The Alachua County Housing Authority (ACHA) is opening the **Mainstream** Housing Choice Voucher (HCV) Program waitlist to the Public for three (3) days starting at 9am, Monday, January 25, 2021 and ending at 5pm, Wednesday, January 27, 2021. The ACHA will only accept 300 applications. **ALL APPLICANTS MUST MEET THE FOLLOWING CRITERIA:**

- 1) Must be a Non-elderly person with disabilities (A person 18 years of age or older and less than 62 years of age, and who):
 - (i) Has a disability, as defined in 42 U.S.C. 423;
 - (ii) Is determined, pursuant to HUD regulations, to have a physical, mental, or emotional impairment that:
 - (A) Is expected to be of long-continued and indefinite duration;
 - (B) Substantially impedes his or her ability to live independently, and
 - (C) Is of such a nature that the ability to live independently could be improved by more suitable housing conditions; or
 - (iii) Has a developmental disability as defined in 42 U.S.C. 6001.
- 2) Must be transitioning out of institutional or other segregated settings, at serious risk of institutionalization, homeless, or at risk of becoming homeless.

Applications must be completed and/or returned to the ACHA office located at 703 NE 1st Street Gainesville, FL 32601 by 5pm, Wednesday, January 27, 2021. Applications will not be available until Monday, January 25, 2021. PROOF OF INCOME, VERIFICATION THAT A HOUSEHOLD MEMBER MEETS THE DISABILITY CRITERIA, PHOTO IDS FOR ALL ADULT HOUSEHOLD MEMBERS, SOCIAL SECURITY CARDS AND BIRTH CERTIFICATES FOR ALL HOUSEHOLD MEMBERS WILL BE REQUIRED AT TIME OF APPLICATION. If you are disabled and require a reasonable accommodation, call (352)372-2549 ext. 545 no later than 1:00pm Friday, January 22, 2021.

Applicants already on a waiting list for other subsidized housing programs are still required to apply for this program if interested in receiving Mainstream Voucher assistance from the ACHA. Applying for the ACHA Mainstream Voucher waitlist will not cause an applicant to lose their place on any other subsidized housing waitlist.

Applications will be placed on the waitlist based on the time and date of receipt of the application.
