## **UPDATED** Request for Quote Tree Maintenance Summer 2025

The Alachua County Housing Authority (ACHA) is looking for a licensed contractor to provide a quote for the removal of hazardous trees and the trimming of additional trees/shrubs under preventative maintenance for units located in their Public Housing neighborhoods throughout Alachua County. Please provide your best price to include all parts, labor, materials, permits, etc. to fully complete the job as described for each location. Price is to include all debris removal including grinding of stumps for locations where the tree/shrub is fully removed. All care should be taken to ensure there are no damages to the yard, sidewalks, buildings, etc. with all disturbed ground repaired. All damages from equipment including but not limited to divots, rutting, broken concrete, etc. must be corrected at the expense of the contractor prior to final payment.

#### General Notes:

- ➤ Work must be completed within 120 calendar days of acceptance of quote and issuance of Notice to Proceed unless mutually adjusted by both parties. ACHA will assist in the notification to residents of all planned work.
- Unless otherwise specified, trimming of shrubs means to cut back away from structures to trunk
- ➤ Unless otherwise specified, trimming of trees means to cut back to trunk or at least 5' from sides and 20' above structures
- > Removal of shrubs/trees means complete removal including stumps (grinding)
- All grounds where work is to be done will be cleaned up and raked out
- All damage to grounds is to be abated by the contractor
- > Tree mitigation to be arranged with ACHA as determined by the municipality

#### Hazards:

There are septic tanks and drain fields located behind units in Alachua, Newberry, Archer and Waldo. Contractor must avoid damaging these structures and will be held responsible for the repair/replacement of damaged components. ACHA to coordinate with awardee.

#### Payments:

- ACHA will make payments to the contractor at the satisfactory completion of each neighborhood as per the "Quote Sheet" on page 9 and 10 of this RFQ.
- All permits are the responsibility of the contractor and must be completed prior to receiving final payment.
